**Call to Order:** David Wytiaz called the meeting to order and welcomed everyone.

**Approval of Minutes:** A motion to approve the minutes of the March meeting was made by Brittney Golden and seconded by Colin Sisk.

**Approval of Financial Report:** The Financial report for February was reviewed. A motion to approve the report was made by Tony Rosatone and seconded by Colin Sisk.

**Director's Report:** Jodi participated in interviews for the new Director of Monaca. They Monaca Board hired Amanda Brobeck as their new director. A motion to approve the credentials of Amanda Brobeck was made by Brittney Golden and seconded by Tony Rosatone.

2025 Affiliation Agreements – Jodi will send messages to library board presidents and directors regarding 2025 System Standards. Jodi will copy Simone, Board president, on the messages.

Debbie Coglio resigned April 14, 2026, so two full-time positions will need to be filled.

A ribbon cutting ceremony for the new StoryWalk at Brady's Run walking track is scheduled for Saturday, May 2, 2026. Courtney has coordinated with the Beaver County Recreation and Tourism Department and the Department of Public Works on the project.

**Business (Old/New):** The Board discussed the Carnegie Free Library of Midland's compliance with 2025 System Standards and not meeting the continuing education (CE) requirements for the director and board. The Board approved a draft letter notifying the library of this noncompliance, including the requirement for the director to complete five CE credits for the prior year in addition to the required 15 credits for the current year.

**Open Discussion:** It was suggested that Courtney create a poster promoting the author event to display at CCBC's graduation ceremony.

Colin and Brittney will not be able to attend the May meeting.
